- 7. **Affirm Theology Committee Members.** The following elders were re-affirmed for three-year terms: Mark Alderton, Walt Alexander, Josh Blount, Rick Gamache, and Matthew Williams.
- 8. **Affirm Court of Appeal Members.** The following elder was re-affirmed for a six -year term: Eric Rangel.
- 9. **Affirm Response Committee for Sexual Misconduct Members. The following** elder was added for a three-year term: Keith Bunting.

The CoE approved by unanimous voice vote, the following motion: On behalf of the elders and churches in Mexico, and with the recommendation of the SGC Leadership Team, and the affirmation of the SGC Executive Committee, Mark Prater moves that the Council of Elders approve Nation status in keeping with section 12.4.23 of the US Book of Church Order that will establish SGC Mexico as an ecclesiastical nation.
- **13. Affirm the Sovereign Grace budget for fiscal year 2023-2024.** Mark Prater presented the FY24 budget for affirmation by the CoE. The Executive Committee reviewed and approved the budget at their retreat in August 2023. The budget was affirmed by unanimous voice vote.
